In supersession of all previous orders on the subject, the rates of payment of remuneration and transportation charges to Resource Persons for training programmes organised by the State Council of Educational Research and Training (SCERT) for various level of officers/officials will be as under:-

I. REMUNERATION

S.NO.	DESCRIPTION/CATEGORY OF FACULTY	REVISED RATES (PER SESSION OF 75 MINUTES DURATION)
1	Professionals /Masters/Recognized trainers of Govt. Of India	Rs.2500/-
2.	Officers of the Central and State Govt. With a Grade Pay of Rs.8700/- and above	Rs. 2500/-
3.	Serving Govt. Officers with a Grade Pay less than Rs.8700/-	Rs. 2000/-
4.	Govt. Officers who hold the rank with a Grade Pay of Rs.8700/- and above, before retirement	Rs.2500/-
5.	Govt. Officers who hold the rank less than a Grade Pay of Rs.8700/- before retirement	Rs. 2000/-

The payment of remuneration at the above rate will be subject to the following conditions:-

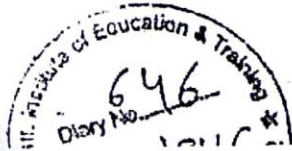
1. The total number of sessions per faculty per financial year will not be more than 30.
2. TDS applicable as per rule will be decided for the remuneration/honorarium paid to faculty.
3. The remuneration is subject to maximum ceiling of Rs. 5000/- per day per Resource Person excluding transportation charges.

II. TRANSPORTATION CHARGES:-

Distance from residence/office to the place of destination and back	
Upto 10 K.M.	Rs.150/-
11 to 20 K.M.	Rs.300/-
21 to 30 K.M.	Rs.450/-
31 to 40 K.M.	Rs.600/-
Above 40 K.M.	Rs.800/-

The payment of transportation charges at the above rate will be subject to the following conditions:-

1. No transportation charges would be payable to the faculty using official vehicles.
2. Outstation faculty who comes to deliver lecture on his/her official tour will not be paid any transportation charges.
